Directions

1. From Points West via Route 80

Take Route 80 East (Local Lanes) to Exit 66 (Hudson Street). Turn left at the stop sign and make next left onto Hudson Street. * Follow Hudson Street 8/10 of a mile to the Courthouse, which you will pass on your right. Bear right onto Main Street (Court Plaza will be on your left). Make first left onto Sussex Street. Halfway down the block, turn left into Court Plaza Garage.

From Points East via Route 80

Take Route 80 West (Local Lanes/Hackensack) to Exit 66 (Hudson Street). Turn left onto Hudson Street and continue at * above.

From George Washington Bridge

Take the bridge to Route 80 West (Local Lanes) and follow directions "From Points East via Route 80" above.

From Lincoln Tunnel

Take Route 495 to New Jersey Turnpike North. Take New Jersey Turnpike North to Route 80 West (Local Lanes). Follow directions "From Points East via Route 80" above.

From Holland Tunnel

Take Routes 1& 9 North to the New Jersey Turnpike North. Take the New Jersey Turnpike North to Route 80 West (Local Lanes). Follow directions "From Points East via Route 80" above.

From Newark Airport

Take the New Jersey Turnpike North to Route 80 West (Local Lanes). and follow directions "From Points East via Route 80" above.

From Points South via the Garden State Parkway or from Rt. 280 in Essex County

Take the Garden State Parkway North to Exit 159 (Route 80). Take Route 80 East and follow directions "From Points West via Route 80" above.

From Points North via the Garden State Parkway or via Rt. 17

Take the Parkway South to Exit 163 (Route 17). Take Route 17 South and exit towards Route 4 East. Take Route 4 East to the Hackensack Avenue Exit. Bear right onto Hackensack Avenue and follow directions "From Points East on Route 4" at *** below.

From the Tappan Zee Bridge

Take the New York Thruway to the Garden State Parkway South (Exit 14A). Follow directions "From Points North via the Garden State Parkway" above.

From Points South via Route 17

Take Route 17 North to the ramp towards Route 4 East. Take Route 4 East to the Hackensack Avenue Exit. Bear right onto Hackensack Avenue and follow directions "From Points East on Route 4" at *** below.

From Points East via Route 4

Take Route 4 West to the Hackensack Avenue Exit. Turn left and go over Route 4 toward Hackensack Business District. ***Follow Hackensack Avenue which becomes River Street. Take River Street to Court Street. Turn right onto Court Street; go to end and turn right onto Main Street. Make immediate left onto Sussex Street. Go halfway down the block and turn left into Court Plaza Garage. There is no charge for parking. The parking attendant may ask you to sign in.

From Points West via Route 4

Take Route 4 East to the Hackensack Avenue Exit. Bear right onto Hackensack Avenue and follow directions "From Points East on Route 4" at *** above.

From Points North via Route 208

Take Route 208 South to Route 4 East and follow directions "From Points West via Route 4" above.

Mass Transit

The office is convenient to forms of public transportation and information regarding schedules and fares can be found at NJ Transit.

Handicap Access

Handicap Access is available through the elevator lobby adjacent to visitor parking on the P-1 level. If arriving by car service or mass transit, handicap access is available via an outdoor elevator located on Main Street to the left of the building (follow signs). The elevator will take you to the Plaza Level where you will be admitted through the Plaza Entry Doors.
